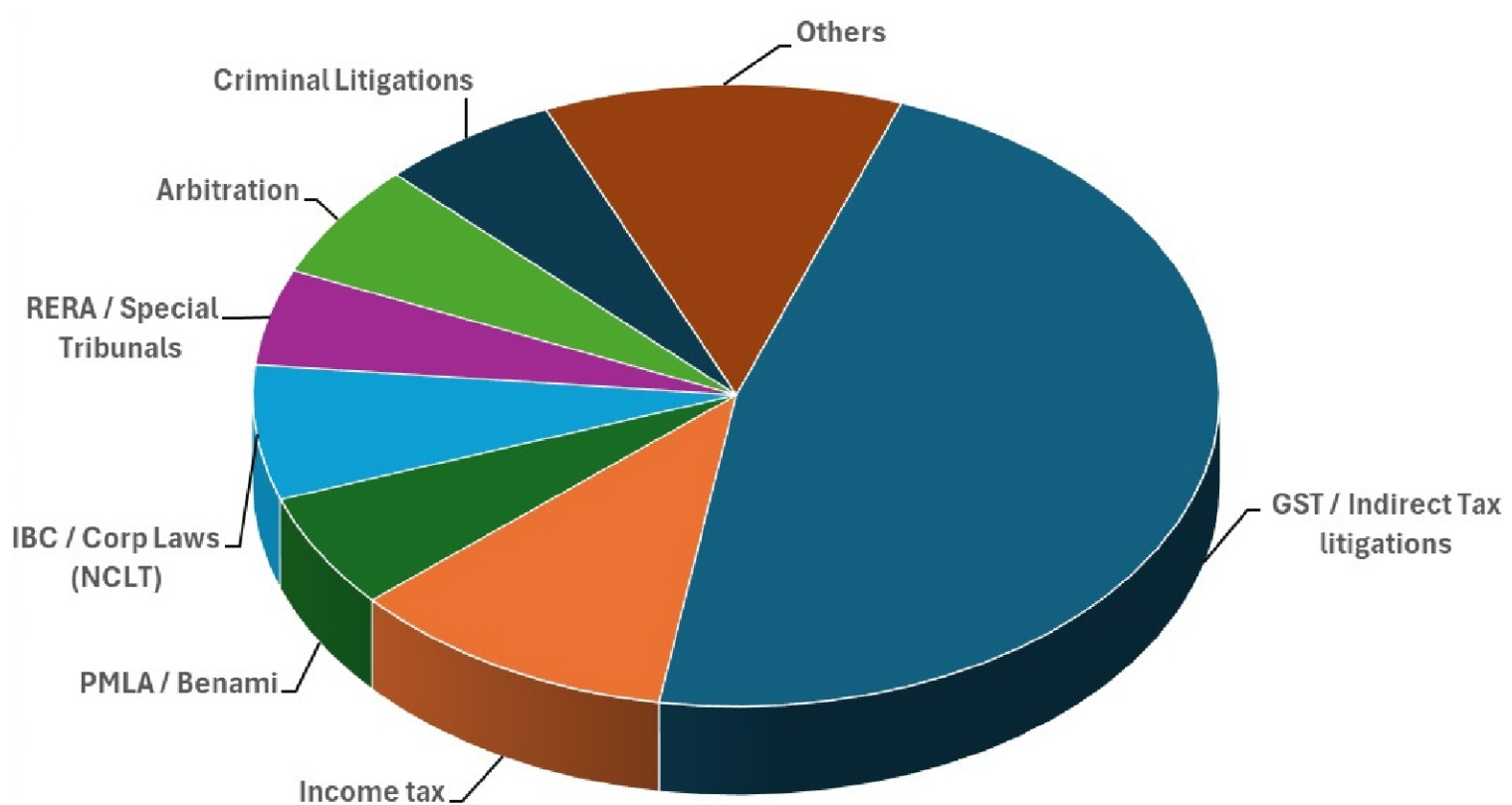

## Journey of ASHVA Legal from 2017 to 2025

We at ASHVA Legal have handled varied assignments for more than 5000 Small & Medium Enterprises, Large Indian Corporates, Multinational Companies, Public Sector Undertaking (PSU), Banks, Cooperative Societies, etc., which includes Handling Search under Income Tax, PMLA, GST by Anti Evasion, Investigation wing, ED & DGGI; Handling Complicated Tax & Compliance issues as Advisors/Consultants and obviously handling Tax & Other litigation matters by representing clients before Adjudicating Authorities, Appellate Forums, Tribunals / Special Tribunals, DRT, NCLT, NCLAT, High Courts and Supreme Court. **Some of the Key issues handled** by team ASHVA are as follows:

### **Appearance before Tribunals & various Courts in Landmark matters – MATTERS ADJUDICATED**

#### **• Whether GSTR 3B is a return under Section 39 of the Act**

- Matter was argued where Hon'ble Gujarat High Court has held that GSTR-3B is not a return u/s 39 of the CGST Act, in **AAP & Co. vs. Union of India**. This was the first Landmark Judgement of GST Regime and the impact of this judgement was that the Government had to amend Rule 61 of the CGST Rules 2017 retrospectively saying GSTR 3B is a return u/s 39 of the Act. Later on due to an observation in Bharti Airtel Limited by Apex Court, the SLP of revenue was allowed and order of Gujarat High Court was not upheld.

#### **• Whether interest under Section 50 of the Act can be levied on Gross Liability**

- We at ASHVA were amongst the first few who challenged the levy of interest on Gross liability. Dr Poddar argued the issue and got the stay from Hon'ble Gujarat High Court. We filed more than 15 petitions on this subject matter before Gujarat, Bombay & Madras High Court. Finally, the Government had to amend the provision of section 50 of the Act retrospectively and clarify that the levy will be on Net Liability i.e. amount being paid in cash and not on Gross Liability.

#### **• Whether Parallel Proceedings both by State & Centre is permissible under GST law**

- This issue was raised during the very initial days of implementation of GST. This issue was taken by ASHVA team & Dr. Poddar argued the matter in which Hon'ble Gujarat High Court was pleased to hold that the authority who initiated the proceeding shall conclude the proceeding. This decision of the Hon'ble Gujarat High Court in the matter of **M/s. Bhawani Textiles** argued by Dr. Poddar, is being quoted on multiple occasions and has become landmark judgement.

#### **• Whether Section 17(5)(d) of the CGST Act is intra vires or ultra vires and therefore whether Input Tax Credit can be availed**

- ASHVA was part of this challenge before Hon'ble Gujarat & Hon'ble Bombay High Court. Dr. Poddar appeared and made submissions on behalf of the petitioners. Finally, the matter went to the Hon'ble Apex Court wherein the vires of the impugned section was declared to be intra vires



by the Apex Court but at the same time theory of Function test was suggested to be applied in order to decide whether ITC can be availed. Again, the impact was that the Government amended the Act retrospectively.

• ***Whether Pre-deposit payable for filing Appeal under GST law can be paid out of Electronic Credit Ledger***

- This issue was taken up by us before the Hon'ble Gujarat High Court. Dr. Poddar argued and the Hon'ble Court conceded with the submissions and held that the payment of pre deposit can be made through the Electronic Credit Ledger in the matter of **Shiv Crackers**. Now this issue is pending before the Hon'ble Apex Court.

• ***Whether Rule 89(5) is ultra vires to the extent it does not allow the refund of accumulated credit on account of input services***

- ASHVA represented various petitioners before the Hon'ble Gujarat and Bombay High Court. Hon'ble Gujarat High Court in a group of matters where lead matter was **VKC Footsteps** and clients of ASHVA were also part of this group, held in favour and declared Rule 89(5) as ultra vires. The revenue challenged the order before the Apex Court by way of SLP. Dr. Poddar represented and made submissions before the Hon'ble Apex Court for the clients of ASHVA. Hon'ble Apex Court allowed the SLP but observed that there seems to be an anomaly in the formula to calculate refund which finally was rectified by the GST Council. Therefore, finally the petitioners got the relief sought with regards to refund of accumulated credit on account of input services.

• ***Whether GST can be levied on Transfer of Leasehold Rights to third Party***

- ASHVA has represented more than 20 petitioners challenging the levy on transfer of leasehold rights. The lead matter was **Gujarat Chamber of Commerce & Industries**, and all other matters were tagged along and heard together Dr. Poddar represented and argued for all the clients of ASHVA. The Hon'ble Gujarat High Court has held that there cannot be any levy as there is no supply. This is another Landmark Judgment of GST where Petitioner got favourable order. Matter is yet to be taken to the Apex Court by the revenue. Dr. Poddar is also arguing this issue before the Hon'ble Bombay High Court which is pending adjudication.

• ***Whether there can be any Recovery of Tax during the course of Search or when the search proceeding is going on.***

- GST Department / DGGI were making the tax payers pay tax as ascertained or estimated by them during the course of search. Most of the times it was observed that the tax payers were made to pay the amount under Coercion. We are extremely happy to inform that Dr. Poddar, Founder of ASHVA Legal was instrumental in addressing this issue. In **Bhumi Associates** the Hon'ble Gujarat High Court issued some strict guidelines which later on culminated into a Circular by CBIC and further Bhumi Associate was followed in many judgements such as Vallabh Textiles by Delhi High Court, where such money recovered during search was ordered to be refunded.

• ***Whether 1/3rd deduction against value of land as provided in Notification No 11/2027 – Central Tax (Rate) is mandatory even where the value of land is ascertainable.***

- This is another landmark judgement by Hon'ble Gujarat High Court, in which in a group consisting of 3 matters, 2 matters were represented and argued by Dr. Poddar lead matter was **Munjal Manish Bhatt**. The question before the Hon'ble Court was whether 1/3rd deduction is to be claimed where the value of land is determinable, the Court held in the negative and accordingly struck down and declared the relevant paragraph of Notification No. 11/2017, insofar as it provided for a one-third deduction from the value of land, as unconstitutional. Now the matter is pending before the Apex Court since revenue filed SLP. One matter in the group was whether plotting project will fall under construction service and GST would be applicable or it will be considered as sale of land. After this, the GST Council clarify that on plotting, there will be NO GST. Credit again goes to Team ASHVA.

• ***Whether an order passed by the authority without fair personal hearing is sustainable.***

- Dr. Poddar successfully argued this issue before various High Courts such as Bombay, Gujarat, Allahabad (Principal Bench & Lucknow Bench), Karnataka (Kalburgi Bench & Principal Bench), Chhattisgarh, Delhi, Jharkhand, Madras, Patna and Punjab & Haryana, where non-compliance of Section 75(4) requirements was challenged and favourable orders were received.

• ***Whether the provision for lapse of credit, under Notification No. 20/2018 – Central Tax, is sustainable in cases where inverted duty refunds are permitted for fabrics and similar items?"***

- Dr. Poddar argued this issue before the Hon'ble Gujarat High Court in which it was held by the Hon'ble Court that there is no provision in law which permits a notification to be issued saying the balance of Input Tax Credit in Electronic Credit Ledger to be lapsed and hence the provision was struck down in the matter of **Shabnam Petrofils**. The revenue filed SLP against the order of Hon'ble Gujarat High Court & the matter is pending to be adjudicated before the Apex Court.

• ***Whether GST refund can be denied on the ground that the Higher Duty Drawback is claimed by the Petitioner.***

- Dr. Poddar argued successfully this issue before Kerala, Madras and Gujarat High Court and got favourable order in various matters. One such instance arose in the matter of **Precot Meridian Limited**.

• ***Whether inadvertent mistake in filing GSTR 1 can be rectified***

- This issue is also represented successfully by ASHVA Legal, Dr. Poddar argued successfully for couple of large corporates before Bombay High Court in the matter of **Rail Road Logistics**, Karnataka High Court in the matter of **ESDS Software Solution Limited** and also before Gujarat High Court.

• ***Bank Account & Property Attachment matters***

- ASHVA has represented countless numbers of such matters before Gujarat High Court, Bombay High Court, Allahabad High Court, Rajasthan High Court & Delhi High Court and got some Landmark judgement such as **Utkarsh Ispat LLP** which travelled till Apex Court, **Madhav Copper Limited**, **Uflix Industries**, **Manish Scrap**, etc.

- **GST Registration matters**

- ASHVA handled multiple matters out of which one that needs to be mentioned specially is matter on behalf of the petitioner **Chartered Accountants Association Surat** where we challenged the delay being caused in granting registration and also the unnecessary documents being asked to grant registration which was causing prejudice to the tax payers. Another landmark was in the matter of **Tesla Multi Trade** where the Hon'ble Gujarat High Court disposed a group of matters where nonspeaking/cryptic orders of Registration Cancellation were under challenge and the Hon'ble Gujarat High Court permitted the invocation of Section 108 in order to resolve the issue.

- **Notification No 09/2023 – Central Tax & Notification No 56/2023 – Central Tax extending limitation to adjudicate u/s 73 of the CGST Act, 2017, Challenged**

- ASHVA Legal is proud that it was pioneer in raising this issue before the Hon'ble Gujarat High Court argued by Dr. Poddar who got the stay on the proceedings and thereafter this issue was taken up in almost all High Courts of the Country. ASHVA also appeared before Gujarat, Delhi, Telangana, Patna and Bombay High Court. Some High Courts have already decided this issue and some are in the process of adjudicating the same. Hon'ble Supreme Court is also dealing with the said question.

- **Whether Rule 96(10) of the CGST Rules 2017 is ultra vires Section 16 of the IGST Act**

- Team ASHVA has challenged on behalf of their clients the validity and vires of Rule 96(10) before Gujarat, Bombay, Telangana & Allahabad High Court. In Gujarat High Court the matters are already heard and reserved for orders. In other Courts the hearing is yet to be concluded. But after omission of Rule 96(10) from the statute book, now there is a likelihood that the Hon'ble Court may decide that omission is to be considered as effective from the retrospective date and therefore no SCN or order would survive as already decided by Uttarakhand High Court.

- **Whether NEET 2024 Exam to be conducted again due to alleged paper compromise at one or two centers**

- Dr. Poddar appeared before the Hon'ble Supreme Court of India, for more than 100 students who qualified NEET 2024 and some amongst them were in Top 100 positions and finally the NEET 2024 exam was not cancelled and students got relief.

- **Section 148A of the Income Tax Act issues, Bank Attachment under section 281B of the Income Tax Act, Assessment of a dead person under Income Tax, Validity & Vires of Section 36(1)(va) of the Income Tax Act, Section 153C issues and many other Income Tax issues are being argued by team ASHVA before various Tribunals & High Courts. Most of these matters are argued by Ms. Anchal Poddar, Founder of ASHVA and CA Vijeta Chaudhary from her team.**

- Dr. Poddar and other Advocates from team ASHVA Appeared and Argued **Bails matters before Court of Sessions and various High Courts.**
- ASHVA Legal represented various matters related to bail and other issues under **PMLA** before PMLA Authority, **Benami Transaction Matters** before Adjudicating Authority, Special Tribunals for PMLA & Benami Transaction matters, etc.
- Team ASHVA Appeared and Argued various Corporate Laws matters before NCLT and NCLAT.

### **Appearance before Tribunals & various Courts in Landmark matters – MATTERS PENDING ADJUDICATION**

- **GST Classifications matters**
  - ASHVA Legal's team is representing multiple classification issues before various High Courts viz. Bombay High Court, Gujarat High Court, Patna High Court, etc. One prominent classification issue being handled and argued by Dr. Poddar is for **Surat District Co-Operative**



**Milk Producers' Union Ltd. (SUMUL)** where classification issue between Dahi & Yogurt. Many other classification issues has been successfully handled & also is being handled by the team ASHVA before different forums.

• ***Whether the balance of Input Tax Credit in the Electronic Credit ledger can be transferred to the amalgamated company where the amalgamating and amalgamated companies are in 2 different States***

- This is a very vital and crucial issue which is being handled by team ASHVA Legal and is being argued by Dr. Poddar before the Goa Bench of Hon'ble Bombay High Court in the matter of **Umicore Autocat India Private Limited**.

• ***Negative Blocking of Electronic Credit Ledger matters***

- Dr. Poddar from Team ASHVA has taken up this issue also before courts and have argued successfully before Gujarat, Bombay (Principal & Aurangabad Bench).

• ***Challenge the validity & vires of Rule 36(4), Section 16(2)(c), Section 16(4), Proviso to Section 16(2) which says if invoice not paid with 180 days, ITC needs to be reversed along with interest & other notifications, etc.***

- These issues are being argued before various High Courts such as Gujarat, Bombay, Telangana, Karnataka, Bombay, Kolkata, Allahabad, Delhi, Uttarakhand and many other Courts. These are pending adjudication.

• ***Whether GST is applicable where Royalty is payable on mining etc.***

- This is also a very crucial issue pending before various High Courts. ASHVA Legal also is having many such briefs which are being argued. ***The following are some of the important issues being argued*** by team ASHVA Legal before various High Courts including Supreme Court.

- *Whether GST is applicable on Corporate Guarantee.*
- *Whether GST is applicable on Cross Charge.*
- *Whether GST would be applicable and payable on the Affiliation Fee paid.*
- *Whether the conditions can be levied in case of GTA and the restrictions can be placed that GTA cannot opt for both Reverse & Forward Charge*
- *Whether the Sub- Contractor providing services to Government Company during 2017 can be taxed at a higher rate than the rate applicable on the main contractor.*
- *Whether issuance of DRC-01A is still mandatory after the amendment in Rule 142(1A)*
- *Whether the Circulars are binding on the GST Authorities.*
- *Whether there can be two proper officer one who can issue Show Cause Notice and one who can issue DRC-01.*
- *Whether single Show Cause Notice can be issued for multiple years.*
- *Whether only uploading of Notice/Order is proper compliance of Section 169 of the Act.*
- *Whether DRC-07 is mandatorily required to be issued along with Order in Original.*
